1 Introduction

This document sets out the fees that apply under the CCB Standards. This document will be updated from time-to-time and readers shall ensure that they are using the most current version of the document.

2 | Fee Schedule

Fee	Rate
Validation fee	Effective from 1 January 2016:
	USD 2,500
Verification fee	Effective from 1 January 2016:
	For each verification event1: USD 5,000
	The verification fee is credited toward future CCB label fees ² .
CCB label fee	USD 0.05 per GHG credit
Retroactive CCB label fee	Effective from 1 July 2015:
	For each retroactive label event ³ :
	USD 0.05 per GHG credit
	USD 1,500 flat fee

¹ A verification event means a project proponent notifies VCS that it has initiated a new verification process (as specified on page 20 of the *Rules for the Use of the CCB Standards*).

² For example, a project that had paid the USD 5,000 verification fee would pay no fees for the first 100,000 CCB labels applied.

 $^{^3}$ A retroactive label event means a voluntary or mandatory retroactive application of the CCB label to previously issued GHG credits. For example, in the case where the CCB label is applied retroactively to 20,000 VCUs, the fee would be: (USD 0.05 x 20,000) + USD 1,500 = USD 2,500.
